

Mississippi Elected Officials



<u>Governor</u> Tate Reeves

Gov. Tate Reeves serves as the 65th Governor of Mississippi. Prior to serving in his current role, he was elected as State Treasurer in 2003 and as the 32nd Lieutenant

Governor in 2011. His history in public service is focused on a commitment to long-term growth that is focused on creating better careers for Mississippians. Gov. Reeves grew up in Rankin County and earned his undergraduate degree from Millsaps College.



<u>Lieutenant</u> <u>Governor</u> Delbert Hosemann

Lt. Governor Delbert Hosemann is a native of Warren County, MS, and has served as Lt. Gov

since 2019. Prior to his term as Lt. Gov., he served as Secretary of State for 12 years. He received an undergraduate degree from the University of Notre Dame, a masters degree from New York University, and a law degree from the University of Mississippi.



State Auditor Shad White

Shad White is known for stopping a major public fraud case in the state's history. He earned an undergraduate degree from the University of Mississippi, a masters degree from the University of Oxford, and a law degree from Harvard Law.



State Treasurer David McRae

David McRae's primary responsibility is to manage the cash flow for state agencies. He earned an undergraduate degree from Southern Methodist University and a law degree from Mississippi College.



<u>Secretary of State</u> <u>Michael Watson</u>

Prior to taking office as Secretary of State in 2020, Michael Watson served three

terms in the State Senate representing Jackson County. As Secretary of State, he is focused on protecting the integrity of Mississippi elections. He grew up on the Gulf Coast and earned an undergraduate degree and law degree from the University of Mississippi.



Commissioner of Agriculture & Commerce Andy Gipson

Before his current office, Gipson served as a State Representative for 10 years. He earned an undergraduate degree and a law degree from Mississippi College.



Insurance Commissioner Mike Chaney Prior to his current office, Chaney spent 15 years serving Mississippi in both the Senate and the House of Representatives. He earned an undergraduate degree from Mississippi State.



Attorney General Lynn Fitch

Prior to serving as the Attorney General, Fitch served at State

Treasurer and Counsel for the House of Representatives. In 2022, she was named one of TIME Magazine's 100 Most Influential People. She earned both her undergraduate degree and law degree from the University of Mississippi.



Senator Dean Kirby

President Pro Tempore

Senator Dean Kirby has served in the Mississippi Legislature since 1992 when he began representing Rankin County. He is an active member in both the Pearl Chamber of Commerce and the Rankin County Chamber of Commerce. He currently serves on the Senate Insurance Committee, Finance Committee, and many others.



Representative Jason White

Speaker of the House

Representative Jason White has served in the Mississippi Legislature since 2012, when he began representing the Mississippi counties of Attala, Carroll, Holmes, and Leake. He is a member of the West Historical & Preservation Society and a member of the Attala County Farmers Co-op. Rep. White earned both his undergraduate degree and law degree from Mississippi College.



Representative Manly Barton

Speaker Pro Tempore

Representative Manly Barton served in the U.S. Army and received the Purple Heart. Before his election to the Mississippi Legislature in 2012, Rep. Barton served as a Jackson County Supervisor and a systems analyst for Chevron. He served on the House Education Committee, House Ethics Committee and numerous others.



Senator Hob Bryan

Public Health and Welfare Chairman

Senator Hob Bryan has served in the Mississippi Legislature since 1984, when he began representing the Northeast Mississippi counties of Lee, Itawamba, and Monroe. He is an active member of the Amory Rotary Club. Sen. Bryan earned his undergraduate degree from Mississippi State University and a law degree from the University of Virginia.



Representative Samuel Creekmore, IV

Public Health and Human Services Chairman

Representative Samuel Creekmore, IV is a member of the American Society of Landscape Architects, the National Federation of Independent Business, and New Albany Sustainability Advisors. He received his undergraduate degree from Mississippi State University. He was elected to the Mississippi Legislature in 2020, and has served on the House Education Committee, House Drug Policy Committee, and many more.

117th day Sat. Apr. 27	Deadline for CONFERENCE REPORTS on APPROPRIATIONS and REVENUE bills to be filed.**+
119th day Mon. Apr. 29	Deadline for FINAL ADOPTION of CONFERENCE REPORTS on APPROPRIATIONS and REVENUE bills, and for CONFERENCE REPORTS on GENERAL BILLS and CONSTITUTIONAL AMENDMENTS to be filed.**+
120th day Tues. Apr. 30	Deadline to DISPOSE OF MOTIONS TO RECONSIDER conference reports on APPROPRIATIONS and REVENUE bills.
121st day Wed. May 01	Deadline for FIRST CONSIDERATION of conference reports on general bills and constitutional amendments.
122nd day Thurs. May 02	Deadline for FILING conference reports on general bills and constitutional amendments that had been RECOMMITTED for further conference.+
123rd day Fri. May 03	Deadline for ADOPTION of conference reports on general bills and constitutional amendments after RECOMMITTAL.
124th day Sat. May 04	Deadline to DISPOSE OF MOTIONS TO RECONSIDER conference reports on general bills and constitutional amendments.
