Fingerprinting Options

Fingerprinting Options

1. Two Standard FD-258 Fingerprint Cards will be mailed to the address the applicant supplies when the application is submitted, and fees are paid. The applicant may have the cards completed at their local law enforcement agency or other fingerprint service provider for processing and return them to the Board.
2. Some law enforcement agencies and other fingerprint service providers will provide the Standard FD-258 fingerprint cards. Once completed, the applicant should submit completed cards to the Board for processing.
3. LiveScan prints can be completed at MSBML. If an applicant selects this option, he or she will be contacted by the Board (once the Board reviews and approves his/her application for licensure) to schedule a LiveScan fingerprinting appointment.
