§73-25-27 Approval of an Investigative Subpoena 01212020LR

Authorization to issue investigative subpoenas pursuant to Miss. Code Ann., §73-25-27, pertaining to an investigation of a license in Case 01212020LR.

A motion was made by Dr. Miles, seconded by Dr. McClendon and carried to close the meeting to consider whether to enter into executive session on this matter.

A motion was made by Dr. Lippincott, seconded by Dr. McClendon and carried that the Board enter into executive session to discuss whether to issue subpoenas regarding investigations of alleged misconduct and violations of the statutes and regulations governing the practice of medicine in case number 01212020LR.

After discussion, a motion was made by Dr. Edney, seconded by Dr. Miles and carried that the Board authorize the issuance of the investigative subpoena in Case No. 01212020LR.


Upon a motion by Dr. McClendon, seconded by Dr. Miles and carried unanimously, the Board came out of executive session.

Dr. Cleveland announced that in executive session the Board unanimously authorized the issuance of the investigative subpoena in Case No. 01212020LR pertaining to allegations of unprofessional conduct and other violations of the Mississippi Medical Practice Act.

Pursuant to Miss. Code Ann., §73-25-27, the Executive Director of the Board is hereby authorized to issue the aforementioned investigative subpoena and this authorization shall be deemed an order entered on the minutes of the Board.
