Acupuncturist Application

Documents Provided by Applicant:

The system should require the following documents to be provided by the applicant and provide a mechanism for the applicant to upload these documents to the online application.

- Affidavit and Perpetual Release form – Indicate acceptance of the oath of truthfulness. Should be signed and notarized.
- Birth Certificate – Should be notarized. If name has changed, must provide notarized evidence of change of name.
- Acupuncture School Diploma – copy of diploma from original PA school.
- Driver's License – copy.
- Foreign Language Documents – for must be translated into English and certified by a recognized translator.
- CPR Certificate – copy of current cardiopulmonary resuscitation certificate.
- Electronic Photograph – in format documented in guidelines on website.
- English Proficiency Exam – for applicants that are graduates of foreign educational programs, a notarized copy of Board approved English proficiency exam scores.
- Proof of citizenship or permanent residency – notarized copy of one of the following: US birth certificate, US passport, Consular Report of Birth Abroad, Certificate of Naturalization, Certificate of Citizenship, US Permanent Resident Card.

Verifications Provided by Third Parties:

These are primary source verifications and are accepted only if sent directly from the applicable institution to MSMBL.

- Appendix B– if holding other state licenses, applicant must request that licensure certification be sent from other states using the form provided.
- Appendix C – form to be submitted by each insurance company where applicant has had malpractice insurance.
- Appendix D – form submitted by applicable institution for each separate activity completed since formal training and occurring within the past 5 years.
