#### MISSISSIPPI STATE BOARD OF MEDICAL LICENSURE

#### PROCLAMATION

WHEREAS, on March 14, 2020, pursuant to the Constitution of the State of Mississippi and Miss Code Ann 33-15-11(b)(17), the Governor of the State of Mississippi issued a Proclamation declaring that a State of Emergency exists in the State of Mississippi as a result of the outbreak of COVID-19; and

WHEREAS, in order to secure emergency / rapid medical licensing early in the pandemic and in anticipation of a possible surge and stress on the Mississippi healthcare system, the Mississippi State Board of Medical Licensure (hereinafter "Board") adopted a series of proclamations; and clarifying that as to in-state physicians, when practicing telemedicine, the requirement for a pre-existing doctor-patient relationship does not apply; and

WHEREAS, on March 15, 2020, the Mississippi State Board of Medical Licensure issued a Proclamation announcing that it would not enforce any statute, rule or regulation requiring physicians to personally examine patients prior to the issuance of a prescription or order for the administration of medication, including control substances, all in an effort to encourage the use of telemedicine during the state of emergency; and

WHEREAS, on March 24, 2020, the Board issued an Amended Proclamation clarifying that until action is taken to lift the emergency, out-of-state physicians may utilize telemedicine when treating patients in Mississippi with whom they already have a pre-existing doctor-patient relationship, without the necessity of securing a license to practice medicine in the state, provided the out-of-state physician holds an unrestricted license to practice medicine in the state in which the physician practices and currently is not the subject of an investigation or disciplinary proceeding and so advises the Board; and

WHEREAS, on April 5, 2020, the Board issued a Supplemental Proclamation further clarifying that the waiver of all Mississippi licensing requirements for out-of-state physicians or physician assistants pertained solely to those whose specialty services such as pulmonologists and nephrologists, are determined to be necessary by the Mississippi Department of Health ("MSDH"); and

WHEREAS, the aforementioned proclamations were designed to suspend certain regulatory requirements in order to give the MSDH the ability and flexibility to promptly and urgently call for specialties needed to cope with COVID on a temporary emergency basis; and

WHEREAS, it has now been over six (6) months and the Mississippi healthcare system has managed without the need for further emergency temporary licensing; and

WHEREAS, in consultation with State Health Officer, there is now no longer a need for any additional or new emergency temporary licensed out-of-state physicians pursuant to the emergency / urgent procedures established by the aforementioned proclamations; and

WHEREAS, the Board recognizes the continuing importance for Mississippi patients to have continued access to their physicians with whom they have an established a doctor / patient relationship; and

WHEREAS, with no ongoing urgent need for emergency / temporary licensing, the importance of resuming established regulatory licensing procedures is needed to protect Mississippi patients and ensure safety and quality of care that the Board is charged with maintaining; and

WHEREAS, to avoid disruption of care, the Board recognizes the need to allow out-ofstate physicians currently holding emergency / temporary licenses pursuant to the previous Proclamations adequate time to submit, and apply for and obtain full unrestricted licensure.

NOW THEREFORE, effective immediately, the previous COVID proclamations dated March 15, 2020, March 24, 2020, and April 5, 2020, are hereby superseded by this Proclamation and are rescinded to the extent consistent with this Proclamation. Regular licensure procedures shall be resumed.

FURTHER, as to those out-of-state physicians who currently hold an emergency license to treat Mississippi patients via telemedicine, such emergency licenses shall remain in full force and effect until January 31, 2021. Those out-of-state physicians holding temporary / emergency licenses wishing to continue to provide care must submit an application for a full unrestricted license on or before December 31, 2020. In the event an applicant is unable to complete the licensure process on or before January 31, 2021, for reasons beyond the applicant's control, the Executive Director of the Board shall have the authority to extend the deadline on a case by case

FURTHER, as to those physicians currently holding a valid unrestricted license to practice medicine in the state of Mississippi, the emergency telemedicine waiver of the requirement of preexisting doctor-patient relationship shall remain until further notice.

FURTHER, as to those physicians currently holding a valid unrestricted license to practice medicine in the state of Mississippi, the emergency telemedicine waiver of the prohibition against prescribing controlled substances, unless otherwise prohibited by law, shall remain until further notice

FURTHER, the Executive Director of the Board shall provide notice of this action to all current holders of licensees by email and on the Board's website

SO ORDERED AND APPROVED by the Mississippi State Board of Medical Licensure, this is the 26th day of October, 2020.

## From the desk of Dr. Kenneth Cleveland, MSBML Executive Director

On March 14,2020, Governor Tate Reeves declared that a State of Emergency existed in Mississippi. At MSBML, this was an expected declaration as the first case of COVID-19 had reached Mississippi a few days earlier. The emergency lockdown had begun, and citizens were instructed to stay at home except for necessities such as food. Businesses throughout Mississippi were closing with only "essential businesses" remaining open. This included the closing of medical clinics to include routine office visits.

Immediately, we knew we had to provide a method for patients to have visits with their doctors, whether the doctors were in state or out of state. Hence, on March 15, 2020, the first of three emergency proclamations was passed in a telephonic Board meeting. This proclamation allowed for a suspension of telemedicine regulations for licensees with an unrestricted license. Additionally, a pathway for emergency licensure for out-of-state physicians with existing Mississippi patients was established.

Although it was always the intention of the Board for only out-of-state physicians with established relationships with Mississippi patients to qualify, it was not clearly spelled out in the first proclamation. This information was listed only on the application that was posted on the website. Only after receiving almost 1,200 applications over a single weekend from physicians as far away as California, did we realize the confusion. Therefore, the second proclamation was passed to clarify the requirement for an existing relationship to obtain an emergency license. This proclamation amendment was passed on March 24, 2020.

During a meeting of the Governor's task force for the pandemic, a concern was raised that if we had an outbreak among physicians, we could potentially fall short on manpower to care for ill patients. What would happen if all the critical care physicians at a hospital were diagnosed with COVID-19? In response to that concern, we passed the third proclamation. This proclamation further clarified that if a specialty, such as pulmonology, was in critical need, the State Health Officer would designate that specialty as critical and we would grant emergency licensure for those specialists without the necessity of a pre-existing patient relationship. This was passed on April 5, 2020, and thankfully there has not been a need to utilize it at this time.

Obviously, we are still fighting this pandemic, but please rest assured that as the conditions that are presented to us change, MSBML will change with them.
