# Registering as a Certifying Physician for Medical Cannabis

Soon after the passage of the Medical Cannabis Act, Dr. Thomas Dobbs, the State Health Officer, reached out to the licensing Boards that would be involved. One of the outcomes of the meetings that followed the initial conversation was that Certifying Practitioners would need to register with their licensing Boards.

MSBML developed a user-friendly system incorporated into our licensing system for physicians and physician assistants to register. The licensee must first register with the MSDH. Once they receive their 10 digit alpha-numeric certification number from the MSDH, they can go into the MELS system and register with MSBML.

For everyone's convenience, the registration process is outlined on the right.

Once you have been issued a Health Department registration number, follow these steps in order to register with the Medical Board:

#### **Medical Cannabis Restrictions**

After the recent passage of the Mississippi Medical Cannabis Act, the MSDH outlined restrictions on the use and distribution of the treatment. This includes registration requirements, background checks, business regulation, and a list of qualifying conditions to participate in the Medical Cannabis Program. - 1.Log in to your Gateway account. This is the same system you use to renew your license. The login page can be accessed via our website, www.msbml.ms.gov, under the Key Links section on the right hand side of the
- 2. If you have forgotten your Username or Password, click the "Forgot username?" or "Forgot password?" link as applicable.

home page. Click the

"Licensure Gateway" link.

- 3. Once you are logged in, click the Green panel on the home page that shows your license number and expiration date.
- 4. On the next page, click the "Medical Cannabis Registration" button under the License Options section.

- 5. Answer the first question. If the answer is NO, you will see a message stating that you must first register with the MS Department of Health. If you answer YES, you will be prompted to enter the Department of Health registration number. The system will validate that the number entered is a 10-digit number.
- 6. Answer the second question. If the answer is NO, you will see a message stating that you must first complete the required 8 hours of continuing education in order to register for Medical Cannabis. If you answer YES, you can continue to the end of the registration process by clicking the "Next" button at the bottom of the page.
